## Invitation of Bids

1. Board of Management is intending to **Purchase of Security Camera System (CCTV) Equipment**. Bids are invited from the interested parties. Details are appended below:-

### "Purchase of Security Camera System (CCTV) Equipment"

2. Bidding/tender documents can be obtained from the office of The Board of Management Multan Industrial Estate Multan up to **26<sup>th</sup> April, 2022** during office working hours from **9AM to 5 PM (Monday to Friday)**. Tender/Bid document cost will be 1,500 rupees. Tender /Bids documents will be available from the date of publication of this advertisement.
3. All tender/bids documents shall be sent in sealed envelope and clearly marked on envelop, "**Purchase of Security Camera System (CCTV) Equipment**".
4. Single stage two envelopes bidding procedure shall be used. The bid shall be in a single package consisting of two separate envelopes, containing separately the Financial & technical proposals. Each envelop shall be marked as "Technical Proposal or Financial proposal".
5. Only those parties shall be eligible those have up to **03 Three years'** experience in the field of suppling IT Equipment.
6. Quality and cost based selection method shall be adopted. The weight for quality will be 70% and 30% will be given to cost. Details of Mark allocation is part of BOQs.
7. All tax & duties of any description shall be inclusive in the quoted amount of bid otherwise tender is liable to be ignored.
8. All tender/bids documents can be sent through courier/Pakistan postal service/or deposited by hand.
9. Tender/bids document shall be reached at the office of Board of Management Multan Industrial Estate, Multan on or before **27<sup>th</sup> April, 2022 up to 11:00 Hours** and tender/bids shall be opened on the same day sharp at **11:30 Hours** in the presence of present parties/or their representatives. No tender/bids document shall be received after **11:00 Hours**. Representative of party shall participate in the bidding process if he/she shall produce authority letter of the party.
10. BID security/Earnest Money of **Rs. 100,560/-** in shape of CDR/Pay Order/ Demand Draft in favor of "**PIEDMC - Multan Industrial Estate**" must be enclosed with tender/bid document, without BID security/Earnest Money tender will be rejected.
11. If Bidder provides false or misleading information shall lead to their disqualification from bidding process.
12. Board of Management Multan Industrial Estate, Multan have right to scrape whole bidding process by invoking clause no 35 of PPRA RULES 2014.
